A total of 18 credits are required for graduation, including: <ol style="list-style-type: none"> (1) Required Courses: <ol style="list-style-type: none"> A. Relevant courses of Epidemiology or Biostatistics (at least 3 credits selected) B. Relevant courses of Data Science (at least 2 credits selected) (2) Seminar of Interdisciplinary Medical Research (2 credits) at least 4 semesters selected. (3) Academic Research Ethics: NYCU's students have to complete the online course of the program and pass the required approval standard for the exam before end of second semester. (4) Gender Equity Education: Students shall take this course during their first semester at NYCU through the University's online learning platform. They shall pass the online test in order to pass the course. (5) Interdisciplinary Medical Research Techniques (1 credit) - in First Fall Semester selected. (6) Research in Interdisciplinary Medical (1 credit) at least one semester selected between passing the qualifying examination and the Application of PhD Degree. 3. All applications for credit transfer(s) must be approved by the institute. The amount of transfer credit(s) shall be less than half of the total required credits for graduation. Relevant details are referred to NYCU regulations. 4. For unaccomplished matters, please refer to the institute regulations.
