| Curriculum and Regulations | <ol style="list-style-type: none"> <li>1. The prerequisite courses of the MBA program include 'Economics', 'Accounting', and 'Statistics'. Students can apply for course waiver by submitting the enrollment test certificates, undergraduate transcripts or other related supporting documents. If the student has not completed the prerequisite courses or the student's waiver application is rejected, the student may take selective courses opened by the Institute to count towards prerequisite course requirements. However, the credits of such courses will not be counted towards the graduation requirement (50 credits).</li> <li>2. The required courses include 'Financial Management', 'Production and Operations Management', 'Marketing Management', 'Human Resource Management', 'Strategic Management', 'Technology and Innovation Management', and 'Research Methods'. Students must not take the above mentioned courses outside of IBM, NYCU unless such courses are not provided in IBM, NYCU in that academic year. The Ph.D. curriculum consists of ‘prerequisite courses’, ‘required courses’, and ‘area-specific courses’.</p> <p>(1) Prerequisite courses: ‘Economics’, ‘Accounting’, and ‘Statistics’.</p> <p>(2) Required courses: ‘theory courses’, ‘methodology courses’ and ‘seminar courses’.</p> <p>1) Theory courses: First-year graduate students are required to complete ‘Management Theory (I)’ and ‘Management Theory (II)’.</p> <p>2) Methodology courses: Students are required to complete ‘Research Methods’, ‘Statistical Methods and Data Analysis’, ‘Multivariate Analysis’, and ‘Econometrics’.</p> <p>3) Seminar courses:<br/> ‘Seminar on Business and Management’ course: Students must complete two semesters of this seminar course.</p> <p>(3) Area-specific courses: Students are required to complete six fundamental courses for the six specified research areas: Business Strategy, Organization &amp; Human Resource, Marketing, Finance, Technology and Information, and Management Science (one fundamental course for each research area), and at least three elective courses related to his/her major research area.</p> <p>The courses taken must include at least three Ph.D. professional courses (nine credits), which include those offered by the Institute as well as those offered by the College of Management. Students shall complete all courses mentioned above prior to application for the Doctoral Final Examination. Students may apply for course waiver, but not credit exemption, of any prerequisite courses, methodology courses, and fundamental courses of the six research areas. If the student has not completed the prerequisite courses or the student’s waiver application is rejected, the student may take elective courses opened by the Institute as prerequisite courses following approval by the Institute. However, the credits of such courses will not be taken into account for the graduation requirement (36 credits). Please refer to the list of Course System for the Ph.D. Program.</p> <p>2. Every student, after passing the Dissertation Proposal Defense and before taking the Doctoral Final Examination, is required to present his/her research progress (including related publication information) every academic year. The presentation date and time is arranged by the Institute.</p> <p>3. Before a doctoral candidate can apply for the Doctoral Final Examination, he/she must meet one of the following requirements for English proficiency:</p> <p>(1) TOEFL Test: 550 or above in TOEFL PBT; 213 or above in TOEFL CBT; 80 or above in TOEFL iBT, or 85 or above in TOEFL iBT MyBest Scores; 8 or above in TOEFL Essentials, or 8.5 or above in TOEFL Essentials MyBest Scores, or the equivalent grades in other forms of TOEFL</p> <p>(2) GEPT Test: High-intermediate or above</p> <p>(3) TOEIC Test: 750 or above</p> <p>(4) IELTS Academic Test: overall 6.5 or above in IELTS Academic, or overall 7 or above in IELTS One Skill Retake, or the equivalent grades in other forms of IELTS Academic</p> <p>(5) The student may complete two doctoral English courses offered by the NYCU Language Teaching and Research Center</p> <p>(6) Students who received their degrees in English-speaking countries may request a waiver for the English language competency requirement mentioned above</p> |
