Other fee requirements:

Students at Grade 6 and Grade 7 of the Department of Medicine, and the current graduates, those at Grade 6 of the Department of Dentistry; the current graduates and those at Grade 4 of the Department of Biotechnology and Laboratory Science in Medicine and Department of Biomedical Imaging and Radiological Sciences, and students at Grade 5 of the Department of Physical Therapy and Assistive Technology, students at Grade 4 (2nd semester) and Grade 5 (2nd semester) of the Department of Pharmacy who take an off-campus internship throughout the semester may apply for tuition and miscellaneous fee reduction by one-fifth.
2. State-financed students at Grades 1-6 of the Department of Medicine may be exempted from fees (tuition and miscellaneous fees, and student group insurance premium in whole).
3. For students with an extended study period admitted before the school year of 2020 (inclusive) who take less than 9 credits (inclusive) on YM Campus, credit fees are calculated based on the number of credits taken by them multiplied by the basic credit fees.
4. The credit fees for courses for 0 credits shall be calculated based on the course hours per week.
5. For students studying individual instruction courses of the Music Institute, personal advisory fees of NT\$11,670 should be charged.
6. Students who study the education program shall pay the education program credit fees separately. The basic credit fees for local students/Overseas Chinese students are NT\$1,200, while the basic education program credit fees for Mainland Chinese students/foreign students are NT\$1,800. Students with an extended study period who take the education program need to pay (basic tuition and miscellaneous fees + basic education program credit fees) * education program credits.

- The basic credit fees for students admitted to the in-service master's programs on CT Campus before 2013 the school year (inclusive) are NT\$5,000.
- Credit fees are payable for courses taken and charged in the following manner:
 - For any student admitted to the in-service master's programs on CT Campus from the school years of 2014-2020 (inclusive): If the students select any degree program of a general department/institute (other than degree programs) for his/her department, the credit fees exclusive for the relevant degree program shall apply. Notwithstanding, if the student selects any other degree program, the credit fees for such degree program shall apply.
 - For students admitted to the in-service master's programs on CT Campus after the 2021 school year (inclusive), and students admitted to the in-service master's programs on YM Campus: The credit fees for the degree programs for the students' departments shall apply.
- Students who take minor courses in any department or institute shall pay the credit fees, which are charged in the manner referred to in Remark 3.
- The basic credit fees for students admitted to the in-service master's programs of Management (Division of Industrial Engineering and Management) from the school years of 2014-2016 are NT\$6,000. The basic credit fees for students admitted to the in-service master's programs of Management (Division of Technology Management) from the school years of 2014-2017 are NT\$6,500. The basic credit fees for students admitted to the in-service master's programs of Management (Division of Business Management) from the school years of 2014-2020 are NT\$6,000. The basic credit fees for the EMBA before the 2021 school year (inclusive) are NT\$10,000.
