## What is a digital diploma? What is its purpose?

## **Definition**

- ✓ A digital diploma is an electronic document that is the official legal equivalent of a paper diploma.
- ✓ Starting from the 2021 academic year, the University will issue digital diplomas in both Chinese and English to graduates who have completed the Graduation Procedure and received a paper diploma.

## **Purpose**

Digital diplomas complement paper diplomas in an era of digitalization, growth in company demand for international recruitment, and pandemic impacts. Digital diplomas can be used for graduation, further education, employment, company verification, further study abroad, etc. Students can quickly provide their diplomas to various organizations for verification of academic qualifications.




## How do I receive a digital diploma?

The digital diploma will be sent to the student's personal e-mail address within 3 working days after the student receives the paper diploma. Students can modify their personal e-mail address in the Graduation Procedure system to receive a digital diploma.



## How do I save the digital diploma?

Please download the original file directly. If the file is opened and then saved as a new one, the verification will not be carried over. The verification function of the digital diploma file is valid forever, so please save the file accordingly. It cannot be printed to be used as a paper diploma, and it cannot receive an official seal from the school.

#### Q1: If the information is incorrect, what should I do?

#### Q3: What should I do if the result is a Verification Alert?

If a reissue, name change, or other alteration has been applied for, the original digital diploma will be flagged as having a new version, so the verification alert will show up. Please use the latest version of the diploma for verification, to get a "Verification Complete" result.



### Q4: What should I do if I didn't receive the digital diploma?

- ✓ For those who did not receive a digital diploma, please contact the Division of Registrar within 1 month of receiving the paper diploma.
- ✓ Those who lost their electronic files within 1 month may apply for them to be resent. If they apply after 1 month, they must apply for them to be reissued.

#### Q5: What are the fees for the digital diploma application?

- ✓ The University is cooperating with the Ministry of Education's digital diploma promotion program, so there is no additional fee for the first delivery of the digital diploma.
- ✓ Students may apply for a replacement due to loss or change of name. Fees are announced yearly.



## Q6: How do I apply for a reissue/name change?

- ✓ Please visit the Division of Registrar website to download the NYCU Updating Personal Information Form to apply for a name change.
- ✓ After the name change is completed, use the online system to apply for the paper and digital diploma to be reissued and complete the remittance payment. The digital diploma replacement certificate will be issued within 3 working days.

#### For:

Graduates who completed the Graduation Procedure after the 2021 academic year and received a paper diploma will be issued a digital diploma in both Chinese and English. Applications will gradually be opened to alumni who graduated before the 2021 academic year, depending on the condition of the system.
