Curriculum and Regulations	<ol> <li>The duration of the in-service master's courses may be extended by 1 to 4 years, but those who have not completed the required courses or completed their degree thesis within the prescribed duration of the course may be extended for 1 year.</li> <li>Graduate students of the in-service master's program should take at least 36 credits, which include the required courses as prescribed by this Institute.</li> <li>The 6 credits of the postgraduate thesis of the in-service master's courses are not included in the 36 required academic degrees.</li> <li><b>Credits waiver:</b> Graduate students who has previously taken the credit courses and obtained a credit certificate, in accordance with the statute, can apply for waive credit when entering the In-service Master Program of this institute. The waive credit should be approved by the Council of the Institute.</li> <li><b>Precautions of credits waiver:</b> <ul> <li>(1) To apply for the credits waiver, students should take at least 1 year of courses in our credit class.</li> <li>(2) Those who have completed the two-year course of our credit class can be waived up to 16 credits; those who have completed the one-year course of our credit class can be waived up to 8 credits.</li> <li>(3) The course name of the waived course must be the same, which instructor must be the same person. If the course name <u>if s</u> different but the content is the same, it can be approved</li> </ul> </li> </ol>
