Minimum Credits	<b>50</b> Credits (including waived courses but excluding the credits of prerequisites courses. No more than 6 course credits are allowed from institutions outside of <b>NYCU</b> ).
Curriculum and Regulations	<p>1. The prerequisite courses of the MBA program include ‘Economics’, ‘Accounting’, and ‘Statistics’. Students can apply for course waiver by submitting the enrollment test certificates, undergraduate transcripts or other related supporting documents. If the student has not completed the prerequisite courses or the student’s waiver application is rejected, the student may take selective courses opened by the Institute to count towards prerequisite course requirements. However, the credits of such courses will not be counted towards the graduation requirement (<b>50</b> credits).</p> <p>2. The required courses include ‘Financial Management’, ‘Production and Operations Management’, ‘Marketing Management’, ‘Human Resource Management’, ‘Strategic Management’, and ‘Technology and Innovation Management’. Students must not take the above mentioned courses outside of <b>IBM, NYCU</b> unless such courses are not provided in <b>IBM, NYCU</b> in that academic year. <b><u>Students may apply for required course waiver by submitting undergraduate transcripts for the Institute to review.</u></b></p> <p>3. Regulations for <b>seminar</b> courses are as follows:                  (1) ‘Seminar on Business and Management’ course is required for <b>one</b> semester.                  (2) ‘Lectures on Business’ is required for two semesters.</p>

應修（應選）課程及符合畢業資格之修課相關規定	<p>一、博士生課程包括先修課程、必修課程及管理專業課程。</p> <p>1. 先修課程：「經濟學」、「會計學」及「統計學」。</p> <p>2. 必修課程：「理論課程」、「方法課程」及「研討課程」。</p> <p>(1) 理論課程：博一生必修「管理理論(一)」及「管理理論(二)」。</p> <p>(2) 方法課程：必修「研究方法」、「統計方法與資料分析」、「多變量分析」及「計量經濟學」。</p> <p>(3) 研討課程：</p> <p>1) 「論文研討」，必修三學期。</p> <p>2) 「個別研究」，擇定論文指導教授後每學年必修至少一次，因出國參加交換學生或赴國外研究或畢業之學年度免修。</p> <p>3. 管理專業課程：由「企業策略」、「組織與人力資源」、「行銷」、「財務」、「科技與資訊」及「營運與決策科學」六組研究領域（以下簡稱領域）中，每領域選修一門基礎課程；另擇定至少一領域為主修領域，自該領域之選修課程中選修至少三門課程。</p> <p>上述各學分須內含修習「博士班專業課程」三門 9 學分（本院各系所所開授之博士班專業課程均予承認並列入「博士班專業課程」學分之計算），且皆須於申請博士學位考試前修畢且及格。「先修課程」、「方法課程」及管理專業課程之「基礎課程」，曾於入學前修習通過之課程可申請免修，但不得抵免。若未曾修過先修課程或其免修申請未獲通過者，經所方同意得以本所開授之選修課程認列為先修課程，惟該學科學分數不得計入畢業學分(36 學分)。課程體系表另附。</p> <p>二、博士生通過論文計劃書口試後，在完成博士學位考試前，每學年應就研究進度（含投稿過程中之相關資料）提出公開報告，報告時間由所方統一安排。</p> <p>三、博士生在完成博士學位考試前，應通過托福(TOEFL)測驗(舊制(Paper-based)成績 550 分(含)以上或後制之對等分數以上)、或全民英檢測驗(中高級(含)以上)、或多益(TOEIC)測驗成績 750 分(含)以上、或選修通過本校語言中心開設之博士班學生英語訓練課程兩門。</p>

Curriculum and Regulations	<p>1. The Ph.D curriculum consists of ‘prerequisite courses’, ‘required courses’, and ‘area-specific courses’.</p> <p>(1) Prerequisite courses: ‘Economics’, ‘Accounting’, and ‘Statistics’.</p> <p>(2) Required courses: ‘theory courses’, ‘methodology courses’ and ‘seminar courses’.</p> <p>1) Theory courses: First-year graduate students are required to complete ‘Management Theory (I)’ and ‘Management Theory (II)’.</p> <p>2) Methodology courses: Students are required to complete ‘Research Methods’, ‘Statistical Methods and Data Analysis’, ‘Multivariate Analysis’, and ‘Econometrics’.</p> <p>3) Seminar courses:</p> <p>a. ‘Seminar on Business and Management’ course: Students must complete three semesters of this seminar course.</p> <p>b. ‘Individual Study’ course: After selecting a thesis advisor, the Ph.D. student shall take ‘Individual Research’ at least once per academic year, except for students participating in overseas exchange programs, overseas research or students who have waived the course in the academic year of graduation.</p> <p>(3) Area-specific courses: Students are required to complete six fundamental courses for the six specified research areas: Business Strategy, Organization &amp; Human Resource, Marketing, Finance, Technology and Information, and Operation and Decision Science (one fundamental course for each research area), and at least three elective courses related to his/her major research area.</p> <p>The courses taken must include at least three Ph.D. professional courses (9 credits), which include those offered by the Institute as well as those offered by the College of Management. Students shall complete all courses mentioned above prior to application for the doctoral comprehensive examination. Students may apply for course waiver, but not credit exemption, of any prerequisite courses, methodology courses, and fundamental courses of the six research areas. If the student has not completed the prerequisite courses or the student’s waiver application is rejected, the student may take elective courses opened by the Institute as prerequisite courses following approval by the Institute. However, the credits of such courses will not be taken into account for the graduation requirement (36 credits). Please refer to the attached list of Course System for the Ph.D. Program.</p> <p>2. Every student, after passing the Dissertation Proposal Defense and before taking the Doctoral Comprehensive Examination, is required to present his/her research progress (including related publishing information) every academic year. The presentation date and time is arranged by the Institute.</p> <p>3. Before a doctoral candidate can apply for the Ph.D. dissertation defense examination, he/she must acquire a grade of 550 or above in paper-based TOEFL, or the equivalent grades in other forms of TOFEL, high-intermediate or above in GEPT, or 750 or above in TOEIC. Alternatively, the student may complete two doctoral English courses offered by the NCTU Language Teaching and Research Center.</p>
