Curriculum and Regulations	<p>I. Mandatory:</p> <ol style="list-style-type: none"> <li>1. Biological Sequence Analysis and High Throughput Technologies, Structural Bioinformatics, Applications of Machine Learning Techniques to Bioinformatics, and Statistical Thermodynamics (choose two).</li> <li>2. Departmental Seminars B: During a one-year term of study there must be two credits taken in this course; for one and a half years, three credits; for two years and above, four credits.</li> <li>3. Thesis in Bioinformatics: During a one-year term of study there must be two credits taken in this course; for one and a half years, three credits; for two years and above, four credits. These credits won't be counted for the total credits required for graduation.</li> <li>4. Special Topic Seminar in Bioinformatics (for MS): Student must have taken 2 credits within term of study, and this course will only count as 2 credits towards graduation regardless of actual credit hours.</li> </ol> <p>II. Regulations on academic credits and course choosing:</p> <ol style="list-style-type: none"> <li>1. Credit exemption will be approved by the Curriculum Committee as per NCTU regulations.</li> <li>2. Students who wish to apply for exemption for required core courses must propose to the Curriculum Committee, who will then deliberate on action.</li> </ol> <p>Any other outstanding issues will be handled by relevant regulations.</p>

Doctoral students of direct-Ph.D. track must finish at least 30 credits (including master's courses completed previously, but excluding Thesis in Bioinformatics and Departmental Seminars), with no less than 24 credits from the home College (excluding Thesis in Bioinformatics and Departmental Seminars.)</li> </ol>
