Curriculum and Regulations	<p>I. Mandatory:</p> <ol style="list-style-type: none"> <li>1. Four required courses: Departmental Seminar A, Thesis in Biological Science and Technology, Advanced Biochemistry &amp; Molecular Biology, and Special Topics Seminar (for MS)</li> <li>2. Departmental Seminar A and Thesis in Biological Science and Technology are counted for one credit each per semester. A total of no fewer than four credits each are required.</li> </ol> <p>II. Regulations on academic credits and course choosing:</p> <ol style="list-style-type: none"> <li>1. For non-biology related courses, there is a limit of three academic credits; the same limit goes for biology-related courses outside of the Department.</li> <li>2. Credit exemption will be approved by the Curriculum Committee as per NCTU regulations.</li> <li>3. Students who wish to apply for exemption for required core courses must propose to the Curriculum Committee, who will then deliberate on action.</li> <li>4. Any other outstanding issues will be handled by relevant regulations.</li> </ol>

應修學分數	<p>(一)、甲組適用</p> <ol style="list-style-type: none"> <li>1. 在規定修業年限內需修滿 15 學分(不含論文研究及專題演講)，其中本院課程不得少於 9 學分(即本院以外各系所學分不得多於 6 學分)；逕行修讀博士學位者至少應修滿 30 學分(含專題演講與碩士班所修課程學分，但不含碩班論文研究)，其中本院課程不得少於 24 學分(不含論文研究及專題演講)。</li> <li>2. 修業期間需完成一門課程及一門實驗課之助教，如有教學經驗者，可提出申請抵免。</li> </ol> <p>(二)、乙組適用(醫學士博士)</p> <ol style="list-style-type: none"> <li>1. 在規定修業年限內需修滿 15 學分(不含論文研究及專題演講)。</li> <li>2. 指導教授為生科院教師者，其本院課程不得少於 9 學分；指導教授為生科院以外教師者，其選修之課程，須於每學期開學後一週內送本系課程委員會審定，而課程委員會應邀請相關之院外教師參與審定。</li> </ol>

Minimum Credits	<p>I. For Division A Students:</p> <ol style="list-style-type: none"> <li>1. Students must complete 15 credits of coursework during their term of study (not including credits of Thesis in Biological Science and Technology and Departmental Seminar A), with no less than 9 credits from home College (therefore no more than 6 credits from other departments and colleges.) Students in direct-Ph.D. track must complete at least 30 credits (including Departmental Seminar A and master's program coursework, but not including Thesis in Biological Science and Technology for master's thesis research), with no less than 24 credits from the College (not including Thesis in Biological Science and Technology and Departmental Seminars A.)</li> <li>2. A student must have served as a teaching assistant for both one regular course and one lab course during their term of study. Those with teaching experience may apply for exemption.</li> </ol> <p>II. For Division B Students (Ph. D. for M. D. program):</p> <ol style="list-style-type: none"> <li>1. Students must complete at least 15 credits (not including Thesis in Biological Science and Technology and Departmental Seminars A) during their term of study.</li> <li>2. For students whose dissertation advisors are from the College of Biological Science and Technology, they must take no fewer than 9 credits from the home College. For students whose dissertation advisors are not from the home College, their course list must be sent to the Curriculum Committee of the Department for review within one week right after each semester begins. The Committee will invite relevant faculty members from outside of the department to participate in the review process.</li> </ol>
Curriculum and Regulations	<p>I. Mandatory:</p> <p>A. For Division A Students: 1. Departmental Seminar A (4 credits) 2. Special Topics Seminar (for Ph.D.) (2 credits) 3. Thesis in Biological Science and Technology (4 credits) 4. Advanced Biochemistry and Molecular Biology</p> <p>B. For Division B Students (Ph. D. for M. D. program): 1. Departmental Seminar A (4 credits) 2. Special Topics Seminar (for Ph.D.) (2 credits)</p> <p>II. Regulations on academic credits and course choosing:</p> <ol style="list-style-type: none"> <li>1. Credit exemption will abide by the NCTU Regulations of Credit Exemption and be decided by the Curriculum Committee.</li> <li>2. Students in Division A have an exemption limit of up to 1/3 of their total required credits.</li> <li>3. Students in Division B will be screened by the Curriculum Committee on course exemption.</li> <li>4. Items not stated herein are subject to relevant regulations.</li> </ol>
