- 二、凡本校學生，均得申請修讀本學程。凡依「學程課程規劃表」選課規定修畢50學分者，由本校發給學程修畢證明。
- 三、本學程主要由科技法律研究所提供課程。
- 四、凡曾經修習相關之法律科目並提出證明者，經召集人同意後得以抵免本學程之學分。
- 五、修習本學程之同學，應於開始修習前至本所辦理學程登記，以利本所進行必要之輔導及學程有關事項之連繫。

Implementation Measures of the Law Program

- I. The Law Program has been established according to the “Guidelines for Establishing Programs for Colleges and Departments” of National Yang Ming Chiao Tung University (NYCU). The Program provides bachelor and graduate students the opportunity to study fundamental subjects of law for the purpose of cultivating the students' specialties in this area.
- II. Students of NYCU can apply to this program. NYTU grants certification acknowledging program completion to the students who have successfully finished at least 50 credit hours according to the “Program Course Schedule.”
- III. The Institute of Technology Law is the primary provider of the Program’s courses.
- IV. . Subject to the approval of the Program’s chairman, credits of related courses of law (with certification) may be counted towards the program’s credit hours requirement.
- V. Students wishing to take the Program should register with the Institute of Technology Law prior to taking courses in order for the Institute to provide necessary information and guidance.
